

Shri Rane said, KhadiPrakritik Paint is a unique product which can serve the twin objectives of employment generation as well as environment

Minister, MSME emphasizes on important role of MSME sector in job creation and expanding manufacturing base

18th Nov.2021: Union
Minister for MSME Shri
Narayan Rane said that the
MSME sector plays a
significant role in terms of job
creation and expanding
manufacturing base. Speaking
at the North East MSME
Conclave in Guwahati on 18th
November, 2021 he said
currently the sector consists of
over 6 crore units employing
over 11 crore people and is a
seminal contributor to the

economic growth with over 30% of contribution to GDP and over 49% of overall exports from India.



Shri Rane said India can develop only when we develop the North-east and it is also the topmost priority of the Ministry of MSME. He also stated that the correlation between the Indian economy



and the MSME sector's performance has never been more aligned. This would continue to grow even closer in the upcoming years. The Minister said given the impact of MSMEs on our economy, it is imperative that push is given to promote entrepreneurship amongst the youth and allow them to play an integral role in development of Indian economy thereby realizing the dream of 5 trillion economy.

Ministers from the State Governments of North Eastern States, who attended the Conclave, also emphasized that such conclaves will help the Region in its efforts towards encouraging entrepreneurship and enhancing competitiveness of the sector in the changed economic scenario. Khadi Sale Breaks All Records; Registers Highest Ever Single-Day Sale of Rs 1.29 crore at CP Showroom

People's massive turnout to purchase local products this festival, in response to Hon'ble Prime Minister's appeal, has done wonders for Khadi. On 30th October, the single-day sale of Khadi at its flagship outlet at Connaught Place, New Delhi, stood at a whopping Rs 1,29,05,000 (Rs 1.29 crore), surpassing all previous records. Earlier, the highest ever single-day sale of Khadi was recorded at Rs 1,28,33,000(Rs 1.28 crore) on 2nd October 2019.

This is the 13th occasion since 2016, when Khadi's single-day sale at one store has exceeded the Rs 1 crore mark. This is also for the 2nd time in October this year that Khadi's sale has exceeded Rs 1 crore; the previous occasion being the Gandhi Jayanti; i.e. 2nd October 2021, with the overall sale value of Rs 1.02 crore.

Chairman KVIC Shri Vinai Kumar Saxena attributed the massive Khadi sale to the Prime Minister's repeated appeals to buy local products. "Khadi is the biggest symbol of "Swadeshi" and Hon'ble Prime Minister's appeal has added to the soaring spirit of Khadi lovers and the festive fervor. The record sale figure of Khadi is a testimony to Khadi's ever-growing acceptability and popularity," Saxena said.

It is noteworthy that the government's push to "Aatmanirbhar Bharat" and "Vocal for Local" in the Covid-19 era has resulted in a manifold rise in the demand of eco-friendly and herbal products. KVIC is constantly adding new products to cater to the growing consumer base, which is also getting reflected through its sale figures.



KVIC to begin Pashmina production soon in Varanasi

30 NOV 2021 New Delhi

The globally acclaimed Pashmina wool products, which are indigenous to the high altitude regions of Leh-Ladakh and Jammu & Kashmir, will now be made in Varanasi also.

In a path breaking initiative, Khadi and Village Industries Commission (KVIC) has roped in 4 Khadi Institutions from Varanasi and Ghazipur districts in Uttar Pradesh for processing Raw Pashmina wool and weaving it further into woollen fabric. The Pashmina fabric will be woven in Varanasi. This is the first ever attempt to introduce the heritage craft of Pashmina weaving outside J&K and familiarize the artisans in the rest of India with this unique art.

Pashmina weaving in Varanasi will commence from January next year. 20 Khadi artisans from Sewapuri Ashram in Varanasi will be given 30days training in Pashmina weaving for which 2 master trainers from West Bengal have been roped in by these institutions. These four Khadi Institutions of Varanasi division have started processing of raw Pashmina wool in Delhi. Nearly 200 KG of Pashmina wool processed in Delhi will be supplied to artisans in Leh by the first week of December. These Leh artisans will spin the wool by December-end that will be brought to Varanasi for weaving. The two artisans coming from West Bengal are highly trained in making Muslin which involves ultra-fine weaving which is very much similar to the weaving of Pashmina.


These 4 khadi institutions taking up the Pahmina Production in Varanasi are: Krishak Gramodyog Vikas Sansthan, Varanasi, Shri Mahadev Khadi Gramodyog Sansthan, Ghazipur, Khadi Kambal udyog sansthan, ghazipur and Gram Sewa Ashram, Ghazipur. These KVIC recognized Khadi

institutions have started procurement of raw Pashmina wool from Leh-Ladakh and brought it to Delhi on 15th November for processing that is de hearing and converting it into roving. The roving will be sent back to the Khadi artisans in Leh for spinning, who have been provided with 100 new model charkhas by KVIC.

The development comes after a meeting of Chairman KVIC Shri Vinai Kumar Saxena with the Lieutenant Governor of Ladakh, Shri RK Mathur recently where LG informed that around 50 MT raw pashmina is produced in Leh-Ladakh per annum out of which, after cleaning and processing, only 15 MT dehaired wool is actually produced for production of Pashmina wool products. Even in just 15 MT dehaired Pashmina wool, a meagre 500 kg quantity, i.e. 0.5 MT only, is utilized in Leh-Ladakh by a few small units for manufacturing of Pashmina products, which is causing loss of employment in Ladakh.



These Khadi institutions of Varanasi have purchased 500 KG of raw Pashmina wool from Leh recently and brought it to Delhi for processing, i.e. dehairing and conversion into roving. Chairman KVIC, Shri Vinai Kumar Saxena said. "this move will not only ensure utilization of entire quality of de-haired Pashmina wool of Ladakh but will also open new job

opportunities for local artisans and availability of genuine and affordable Pashmina wool products in Varanasi. KVIC will provide online marketing support also to these khadi institutions. This will be a path-breaking initiative as the production of Pashmina would, for the first time, be done outside the J&K and Leh-Ladakh region."

The processing of Raw Pashmina wool at Delhi was launched on 20th November by Chairman KVIC. The processed Pashmina wool would be

supplied back to the artisans in Leh-Ladakh. The Pashmina Raw Wool Processing Centre in Delhi will ensure round the year supply of pashmina roving to the artisans in Leh-Ladakh where all activities remain suspended for six months owing to extreme cold.

The All Chang Thang Pashmina Growers Marketing Cooperative Society, Leh, from where Khadi Institutions are procuring raw Pashmina

Employment Opportunities in Rural Areas

29 November, 2021 New Delhi

On 1st July, 2020, after adoption of new definition of MSMEs, a new registration portal 'Udyam Registration' has been launched by M/o MSME and so far 2,93,226 and 32,938 classified enterprises are registered in India as Small and Medium respectively on the portal (from 01.07.2020 to 23.11.2021).

As per 73rd Round of NSS Report on Unincorporated Non-Agricultural Enterprises (July 2015- June 2016) conducted by Ministry of Statistics & amp; PI, estimated number of MSMEs was 6.34 crore and estimated number of workers in MSME sector was 11.10 crore.

The MSME sector is an important sector of the

Indian economy. The Ministry of Micro, Small and Medium Enterprises (MSMEs) implements various schemes for the growth and development of MSME sector in the country including rural areas. These included Micro and Small Enterprises-Cluster Development Programme (MSE-CDP), Scheme of Fund for Regeneration of Traditional Industries (SFURTI), Credit Guarantee Fund Trust for Micro and Small Enterprises (CGTMSE) and A Scheme for Promoting Innovation, Rural Industry & amp; Entrepreneurship (ASPIRE).

This information was given by the Minister for Micro, Small and Medium Enterprises Shri Narayan Rane in a written reply to Rajya Sabha on 29 November, 2021.

wool, has also welcomed the move saying this would support the local artisans of Leh-Ladakh. "We have supplied 500 KG of raw wool to KVIC and any further demand for raw wool will also be met as this would ensure adequate work to the Khadi artisans in Leh-Ladakh and also strengthen the local Pashmina industry," said Mr Thinlay, Secretary of All Chang Thang Pashmina Growers Marketing Cooperative Society, Leh.


KVIC, after one-month training, provided 100 new model charkhas of 8-spindle to the local artisans in 4 villages of Leh-Ladakh to start the spinning activities of Pashmina wool. These villages are: Likir, Saspol, Shakti and Leh city. These 4 institutions from Varanasi division have adopted the artisans and as a special case, have decided to pay Rs 20 per hank spinning charges.

At present, artisans working on traditional charkha in leh-Ladakh can produce only 2-3 hanks of Pashmina wool per day and earn less than Rs 100 per day. But now on the 8-spindle new model charkhas provided by KVIC, artisans will produce up to 15 hanks per day and earn up to Rs 300 per day.

Khadi artisans in Leh who have been provided charkha by KVIC, said this initiative of KVIC would ensure round the year work to us in Leh-Ladakh that would result in higher wages and our financial sustainability.

KVIC has also provided 25 high quality 48 inch width looms in Leh which will not only minimize the effort in weaving for artisans but will also produce all sizes of fabric. KVIC will further deploy more charkhas as soon as the work increases.



31 Khadi Prakritik Plant Units in Chattisgarh and Haryana to increase Farmers' income and accelerate rural economy



The unique Khadi Prakritik Paint developed by Khadi and Village Industries Commission (KVIC) using cow dung as raw material has been adopted by the state governments of Chhattisgarh and Haryana as a model of sustainable employment.

A total of 31 Prakritik Paint manufacturing units – 25 in Chhattisgarh and 6 in Haryana – will be set up by the respective state governments soon, for which technology transfer agreements have been signed with KVIC. Chhattisgarh government signed the MoU with KVIC on 21st November 2021, in presence of Chief Minister of Chhattisgarh, Shri Bhupesh Baghel. The MoU with the Haryana Government was signed on 12th Nov.The first Prakritik Paint unit in Haryana has been set up at Pinjore near Chandigarh where over 6000 liters of Prakritik Paint has already been

produced. Another 5 paint manufacturing units will be set up by March 2022. The Chhattisgarh government, in addition to the 25 paint manufacturing units, will also set up 75 units for manufacturing

Carboxy Methyl Cellulose (CMC), which is a major component of the Prakritik Paint.

These new paint manufacturing units will have a capacity of producing 500 liters of paint every day. The 31 new Prakritik Paint units in the two states will produce approx. 50 lakh liters of paint annually while creating nearly 500 direct employments supporting several other allied sectors. KVIC's Kumarappa National Handmade Paper Institute (KNHPI), Jaipur, which has developed the Prakritik Paint, will provide training to the skilled workers from these states in making the cow dung Paint.

KVIC Chairman Shri Vinai Kumar Saxena said Khadi Prakritik Paint is an effective model of sustainable employment and that Chhattisgarh and Haryana will set examples for other states to set up cow dung based Prakritik Paint units. "Khadi

Prakritik Paint is an eco-friendly and costeffective product with great potential of creating sustainable employment and increasing the income of farmers, which is the dream of Prime Minister. The prime objective of developing cowdung paint is employment generation which is the basic premise of Khadi. The cow dung purchased from farmers and cow sheds for manufacturing of Prakritik Paint will create additional income of nearly Rs 30,000 per animal per year," Saxena said.

Khadi Prakritik Paint was launched on 12th January 2021. Apart from being waterproof and washable, the paint contains the natural benefits of cow dung like anti-bacterial, anti-fungal and natural thermal insulation properties. This paint is eco-friendly, non-toxic, odorless and cost-effective.



PRIME MINISTER'S EMPLOYMENT GENERATION PROGRAMME (PMEGP)

A flagship programme to provide sustainable employment through setting up of new self-employment ventures

The Scheme is being implemented by Khadi and Village Industries Commission (KVIC), under the administrative control of the Ministry of MSME as the single nodal agency at the National level. At the State level, the Scheme is implemented through State KVIC Directorates, State Khadi and Village Industries Boards (KVIBs) in rural areas and District Industries Centres (DICs) in both rural and urban areas and Coir Board for coir activities. The Government subsidy under the scheme is routed by KVIC through the identified Banks for eventual distribution to the beneficiaries/entrepreneurs in their Bank accounts.

Objectives

(I) Generate employment opportunities in rural as well as urban areas of the country through setting up of new self-employment ventures/projects/

- (ii) Bring together widely dispersed traditional artisans/rural and urban unemployed youth and give them self-employment opportunities to the extent possible, at their place.
- (iii) Provide continuous and sustainable employment to a large segment of traditional and prospective artisans and rural and urban unemployed youth in the country, so as to help arrest migration of rural youth to urban areas.
- (iv) Increase the wage earning capacity of artisans and contribute to increase in the growth rate of rural and urban employment.

Quantum and nature of financial assistance

I. Margin Money Subsidy

- (I) Funds are being allocated under annual Budget Estimates towards disbursement of Margin Money for setting up of new micro enterprises (units); and
- (ii) From the funds allocated under BE for the Margin Money Subsidy, Rs.100 Cr or as approved by the competent authority will be earmarked for each FY towards disbursement of Margin Money for upgradation of existing PMEGP units.

II. Backward and Forward



Linkages

5% of the total allocation under BE for a Financial Year against the PMEGP shall be earmarked as funds under Backward and Forward Linkages and are being utilized for arranging awareness camps, exhibitions, bankers meeting, TA/DA, Publicity, EDP, Physical Verification, concurrent evaluation, etc. and settlement of other residual liabilities by the KVIC.

Levels of funding under PMEGP

(I) For setting up of new Micro Enterprise (units)

- (2) The maximum cost of the project/unit issible under business/service sector is Rs. 10 lakh.
- (3) The balance amount of the total project cost will be provided by Banks as term loan.

Eligibility conditions of beneficiaries for PMEGP new enterprises (Units)

- · Any individual, above 18 years of age
- There will be no income ceiling for assistance for setting up projects under PMEGP.
- · For setting up of project costing above Rs.10
