

KVIC is setting up modern high end Khadi outlet named Khadi lounge which will showcase designer line of garments and exclusive fabric for men and women in major metropolitan cities. The first of these



outlet has been designed and set up in the premises of KVIC at Vile Parle, Mumbai. The designer wear includes high fashion garments including ready to wear

garments designed by Ritu Beri, the acclaimed fashion designer.

This store will provide Khadi a niche among the fashion conscious Mumbaikars and trend conscious youth with modern hand spun fabric and garments. Similar such high end stores have been set up in Delhi and Jaipur. The idea of Lounge series of Khadi outlet is to showcase Country's best handcrafted fabric and products in the modern outlet.

Oon his Maiden visit to Central Office KVIC the MoS, said that buying one piece of cloth will generate employment for one artisan. He said, as on today MSME is generating 94% employment and only 4% is done by public sector. Not only this, 65%





of GDP growth is from MSME sector. Walking with pace of time all the product information, procure system is being developed digitally.

He also informed that entrepreneurs ZED (zero defects, zero effect) movement is being taken up by MSME "At least 10 lakh units should come forward. We have set 50 parameters to meet ZED certification standard. The banks are instructed for generating one entrepreneur from SC/ST and women from each branch, he added.

Creating healthy competition for quality production is another agenda of MSME. For this five types of awards will be given to best performer from

MSME sector, he added. On this occasion he also released KVIC Diary and Calendar of 2017.

Commenting on this initiative Shri Vinai Kumar Saxena, Chairman KVIC said, the Khadi lounge opening at Delhi, Mumbai and Jaipur which will stock premium collection of elegant and stylish Khadi silk and newly designed Ready-mades will satisfy the quest of Khadi lovers. With this KVIC reconfirms its commitment towards 'Make in India' initiative aligned with Prime Minister's vision for Khadi. This will create multiple employment opportunities and will empower the artisans, especially women in rural India by selling their premium products."

Shri Saxena also informed about launching of cashless digital payment system like Paytm.

Ms Usha Suresh, CEO, KVIC said "KVIC has taken this initiative to implement the mission of our Prime Minister for making Khadi a fashionable

garment. This lounge will cater to the taste of the fashionistas and will promote the

sales of khadi to a significant extent will empower the artisans and enrich their livelihood".

Jaipur gets City's first Khadi lounge





Chairman, KVIC Shri Vinai Kumar Saxena inaugurated Jaipur's first Khadi India lounge in Jhalana, Doongri, Jaipur. The outlet will stock premium collection of khadi —made outfits like khadi silk sarees and Pashmina clothes among others. The first Khadi lounge outlet in the series was launched recently in Mumbai.

"It is our attempt to make the outlets modern with better staff ambience. We have renovated about 178 outlets in past one year across the Country. The main purpose of these outlets is to give feel good factors to all those who visit these outlets. They should also know that this is our national and heritage fabric. we also want our youth to understand the value of our self made fabric and slowly accepted it" he explained.

KVIC has also requested the Govt to include Khadi manufacturing in the MANREGA Scheme. KVIC will not only provide more than a 30 days employment to the applicants unlike the regular





scheme which provides 100 days of employment but will also make labourers skilled and income of artisans enhanced, Shri Saxena informed.

The Chairman also briefed on the "heritage charkha" museum which will be launched very soon in New Delhi.

People who own charkha have been asked to donate it to KVIC. They will be displayed in the museum with the owner's name and title. So far we have received 19 charkhas that range from 55 to 104 years old. we have also installed a charkha made of stainless steel at Pallika Bazaar which is about 8 meters wide and 4.5 meters tall. It will not be ruined by rain or sun, he added.

Exhibition on CHAMPARAN SATYAGRAH in Motihami



The first Satyagraha movement inspired by Mahatma Gandhi occurred in Champaran district of Bihar and the Kheda district of Gujarat in 1917 to 1918. KVIC is actively involved in materializing Mahatma Gandhiji's dream into reality. Working in this direction an exhibition was organized from 30. 01.2017 to 13.02.2017 jointly by KVIC and District Khadi and Gramodyog Sangh in Motihari.

The exhibition was inaugurated by Shri Radha Mohan Singh, Union Minister for Agriculture and Farmers Welfare and presided by Shri Vinai Kumar Saxena, Chairman, KVIC.

In his inaugural address Shri Radha Singh said, Gandhiji always dreamt of eradicating poverty through Charkha. The activities of Khadi and Village Industries have always focused on generating employment through its various



programmes. He informed that, to connect Motihari w i t h e m p l o y m e n t Generation 200 charkhas and 20 looms will be distributed in the district. Besides

this under the budget 2016-17 Rs. 1.19 crores have been recommended. Not only this 350 artisans will trained in operating solar Charkha and connected with PMEGP programme of KVIC. He also briefed on progress and development of PMEGP in Motihari district.

The Minister also informed that Gandhiji's Charkha will be installed at the entry gate of Motihari district in the centenary year of Champaran.


For this KVIC will provide Rs. 1.00 crore. On this occasion other dignitaries present on dias also expressed their views on Champaran Satyagrah.

Environment (all independent charge) and Urban Development, Govt of Gujarat, and Shri Bipin Patel, Managing Director, Banas Dairy, Palanpur.

Around 600 peasants from functioning of Banaskantha and Patan District were educated on beekeeping industry by technocrats from Pune beekeeping Centre of KVIC.

Shri Bhakarbhai Chaudhary called this initiative a good opportunity for the local people.

Addressing the workshop Chairman, KVIC applauded the *Sweet Kranti* vision of Hon'ble Prime Minister which has been started from Patan-Banaskantha and assured for all technical support from KVIC.

Abide your responsibilities with positive mind-set -Chairman KVIC



Mumbai,19th January 2017: Abiding your responsibilities with positive mind-set will make KVIC successful, I can do it ought to be the attitude said Shri Vinai Kumar, Saxena, Chairman, in his inaugural address of KVIC's State/Divisional Directors Conference organized here today. 'This Orgaisation holds great onus and test of performing on the faith shown by the Hon'ble Prime Minister, he added. The brain storming in this conference will help in solving the difficulties and heading towards new goal

Speaking further he said that KVIC has a huge work force which can attain any set goal. Hence all the State and Divisional Directors should work like a soldier. This Organisation has a capacity to generate employment even at places which lack even fundamental amenities. The need of the hour is to understand this commitment, caliber and notion, he opined. Even today KVIC can provide employment with the Spinning wheel which costs just Rs. 13.500 and loom which costs just Rs. 3500 said the

Chairman. He also stressed that C.S.R. will play a major role in getting new identity to KVIC we need to be optimistic for attending the goal.

Addressing the conference Ms.Usha Suresh, C.E.O./F.A., KVIC, Mumbai said since this is third quarter of the financial year, to achieve the said targets we need to be optimistic, The budget allocated from the Ministry should be spent in this financial year itself, as the coming GST and PFMS Scheme



will change the whole parameters. To attend the goal we need to gear up so that, we are not left behind in the year 2017-18 in achieving our goal. Before implementation of GST all our schemes should be on line. There is need to introduce integrated financing system for making the entire system transparent, she added.





Jt.CEO, Shri Satpal informed that, MDA Scheme will be started in this quarter. Last year, target of PMEGP was a 500 crores which should be achieved this year itself. 180 Institutions have taken the advantage of KRDP scheme, whereas our target is 400 institutions. Our efforts are on to link Khadi institutions with this scheme. Institutions who have more than 50 Artisans will also be included in this scheme. The target is to add at least 600 institutions, he added.

KVIC has set landmarks in Marketing Areas like introducing e-commerce on line portal etc. This year, KVIC marked sale of Rs.1800 crores of Khadi and V.I.Products. The cashless scheme has brought more transparency in the area of marketing. The online Khadi Certification, Registration has added 40 new institutions, he said.



Dy.C.E.O. (PMEGP), Shri K.S.Rao, on this occasion, reviewed the targets and achievements of PMEGP Schemes with State/Divisional Directors and urged to achieve their said targets in the third quarter of this year. He also said that just forwarding the applications will not fulfill their role instead after conducting EDP and distribution of Margin Money will only complete their role.

He also informed that the rule of completion of EDP Programme has flexibility in North East Region only.



Shri Y.K.Baramatikar, Dy.C.E.O. (Administration) assured that, the force of KVIC will put all its efforts to fulfill the target and achieve the goal.

Earlier, on the first day of the State/Divisional Conference all the State/Divisional Directors presented the progress of the Schemes and Programmes implemented in their region and also presented the difficulties and hurdles faced. On 2nd day of Conference, Shri B.H.Anil Kumar, Jt. Secretary, Ministry of MSME, Govt. of India, New Delhi reviewed the progress of the scheme in presence of Ms. Usha Suresh, FA, KVIC. He also directed to fulfill the target within set time period and directions.

Three corner compounded benefit: Hallmark of a new agreement between ONGC and KVIC



The Oil and Natural Gas Commission (ONGC) usually distributes annual bonus to its employees in the form of cash, recognizing their services to the nation and rewarding their hardwork. This year, an agreement has been reached with the Khadi and Village Industries Commission (KVIC),

under which while the staff bonus gains an additional value, the mechanism itself contributes to a wider public good.

Shri V.K. Saxena, Chairman of KVIC said that his negotiations have led to ONGC deciding to reward its employees in kind, at a value that is over three fold higher than the cash value. Under the scheme, the ONGC will provide Khadi vouchers worth Rs. 10,000 each to its regular employees and Rs. 5,000 each to its non-regular employees. The KVIC will allow an additional 35%

incentive on these vouchers, thus enhancing the value of ONGC bonus to 135% of its cash value for its staff. These Khadi vouchers can be used by ONGC staff over a period of 2 months.

ONGC has 34,236 regular employees and 1,063 non-regular employees totalling to 35299. As a result, KVIC will get Rs.35 crore payment from ONGC due to this initiative. Considering 35% additional supplement by KVIC, the total sale of KVIC products will be about Rs. 47 crores over a period of 2 months in which @ 22%, i.e Rs 10 cror will be the

wages. Saxena said that the Artisans attached to this special sales drive will be given an additional 5% reward directly in their accounts through DBT.

KVIC will provide best quality Khadi products through 16 special exhibitions within the





ONGC premises, so that the ONGC employees would get the products at their doorsteps. KVIC has also decided that the local Khadi Institutions and PMEGP units of the relevant area will be roped in to showcase their best products in these exhibitions, thereby spreading the benefits to local artisans. Efforts would also be made to ensure that 70-80 per cent of the sale would be of readymade garments, with special focus on women and children of the employees.

The first such exhibitions will start from 16 January 2017 from Mehsana in Gujarat and will cover ONGC Locations at Ahmedabad, Vadodara, Ankleshwar, Hazira, and Cambay Basin up to 14th Feb 2017 .ONGC has highest numbers of employees i.e 11,081 in Gujarat. Similarly, in Maharashtra, the ONGC has 6,783 employees and exhibitions will



simultaneously start from 16 January to 28th February 2017 at various locations. KVIC has prepared a calendar for exhibitions in Andhra Pradesh, Pondicherry, Tripura, Tamil Nadu, West Bangal, Jharkhand and Goa in consultation with ONGC and formulated 4 teams to start exhibitions simultaneously in 4 places.

Besides the tripartite benefit - sales to KVIC, value for money for employees and staff goodwill to ONGC, the agreement will prove to be a unique model that helps in the sustainable development of rural artisan communities. Apart from higher productivity, the rural communities will also earn more and sustain a better quality of life. KVIC, through this unique



Lakhs extra mandays for its Khadi artisans, increasing employment opportunities.

Hailed in both the business and social circles as a unique experiment of multi level sustainable development, the scheme highlights a model of socio-economic rewards for the producer and the consumer alike. Shri Saxena also explained that the scheme embodies the Prime Minister's often repeated principle - `Sabka Saath, Sabka Vikas`.

Commission also directed that all State/Divisional Directors should ensure that details about the mortgage of the properties by Khadi Institution are duly recorded in the Revenue records of the Office of the Registrar concerned so as to prevent irregular/unauthorized sale of properties by Office Bearers of Khadi Institutions. Time bound action plan should be drawn for completion of the same.

On proposal of directorate of reform implementation division (RID) regarding relaxation of conditions in circular dated 19.12.2016 on the issue of revised selection criteria for considering new khadi institutions under KRDP programme, Commission deliberated on the proposal of Directorate of Reform Implementation Division regarding relaxation of conditions in Circular dated 19.12.2016 on the issue of revised selection criteria for considering new khadi institutions under KRDP Programme keeping in view that out of a target of 400 Khadi Institutions(KI's) that had to be assisted under the KRDP programme only 235 KIs have been sanctioned DRA till date.

In order to ensure that the target is achieved, Commission approved relaxation in conditions of selection criteria of KI's under KRDP as detailed below:-

- a. Newly registered Khadi Institutions who have availed inadequate bank finance shall be considered for DRA under KRDP.
- b. Newly registered Khadi Institutions will be exempted from Categorization.

- c. The production turnover of Khadi Institutions to be considered under the KRDP programme was relaxed to at least Rs. 25.00 Lakh per annum during last three years.
- d. Weightage criteria for recategorization of existing khadi institutions need to be reviewed in order to make them eligible for assistance under KRDP Programme.
- e. The minimum number of registered artisans with the institutions eligible for DRA should be 50.
- 8. On budget guidelines for fixing target of khadi institutions (ki's) for the year 2017-18, Commission took note of observations of Member (CZ) regarding Budget Guidelines for fixing target of Khadi Institutions for the year 2017-18 issued vide Circular No. BGT/Budget Guideline 2017-18 dated 16.01.2017 where at Para No. 6 of the circular it is mentioned that State / Divisional Directors will first issue the budget allocation to Khadi Institutions for the respective financial year and then the budget allocation will be placed with the Zonal Committees for information.

In this connection Member(CZ) observed that once the budget allocation has been finalized and communicated by the State / Divisional Directors then there is no point in placing the same in the Zonal Committee as any modification / revision suggested by the Zonal Committee will be embarrassing for State/ Divisional Directors to revise / implement after already having communicated the allocation to the Khadi Institutions.

641st Commission meeting

The 641st Meeting of the Khadi and Village Industries Commission was held on 25th January 2017, at New Delhi presided over by Shri Vinai Kumar Saxena, Chairman, KVIC. - action plan on national beekeeping development mission (honeybee mission) for a period of 5 years and forwarding the same to PMO through Ministry of MSME Commission deliberated on the proposal in detail and accorded in-principle approval to the proposed action plan for implementing National Beekeeping Development Honeybee Mission during the five year period from 2017-18 to 2021-22 with an overall financial outlay of Rs. 859.17 Crores and directed that the proposal may be forwarded to Ministry of MSME for further actions.
- a. Commission also accorded in-principle approval to the proposed Action Plan under National Beekeeping Development Honeybee Mission for the year 2017-18, with a financial outlay of Rs. 164.18 Crores
- b. Commission agreed with observations of Economic Advisor (MSME) that the spread of the mission should be more in the Himalayan foot hills, Himachal Pradesh, Uttarakhand and North Eastern Region of the country. Commission also decided to segregate the old

- bee keeping extension centres and focus on setting up new bee keeping extension centres while executing the action plan.
- c. Commission also advised to revise the Action Plan for a shorter period of 2 years with a target to associate 1.00 Crore beekeepers in the project.
- d. Commission also decided to develop Banaskantha District of Gujarat as a "Model Beekeeping District" under 'Sweet Kranti' programme of Hon'ble Prime Minister.
- 2. On certification, explaining the disparity in the fee charged for khadi mark registration and new khadi certificate Commission deliberated and approved the proposal of Directorate of Khadi Certification, regarding enhancement of Khadi Mark Registration Fee of the category of individuals, PMEGP Entrepreneurs and other eligible entities who are not covered under limited, private or partnership companies or khadi institutions from Rs. 25,000/- to Rs. 50,000/-

Commission took note of observations of Member(CZ) that when Commission is in existence the power to issue/sign the Khadi Certificates



should be vested with Chairman of the respective Zonal Committees rather than Dy.CEOs of respective Zones who are issuing / signing the certificates at present.

It was informed that as per the ADB assisted KRDP conditions, it was decided to delegate the certification of khadi institutions to Directorates within KVIC. Commission therefore directed to submit a report on the issue of appropriate authority to issue / sign khadi certificates as per provisions of Act and place the same in the next Meeting of the Commission for consideration.

After detail deliberation Commission decided that Budget Allocations will be issued by State /Divisional Directors only with the approval of Zonal Committee.

Accordingly, Para No. 6 of the Circular under reference has been modified to read as below:-

"The State/Divisional Directors shall complete the budget exercise of fixing the targets within 28th February, 2017. The consolidated statement in the prescribed Form-I for Khadi and Form-II for Village Industry separately for DAI & BAI to be forwarded to the Zonal Offices for placing in the Zonal Committee Meeting before 15th March, 2017. With the approval of the Zonal Committee only, State/ Divisional Directors shall issue budget allocations in favour of DAI's and BAI's. The budget allocation should be consistant with the infrastructure available, raw materials artisans etc. Where Zonal Committee is not constituted the budget allocation may be issued with the approval of Zonal Dy. CEO. Thereafter the Consolidated statement shall be forwarded to the Central Office to the respective Programme Directors before 31st March 2017."

9. On consultation with expert member (mkt) on all major marketing issues, Commission took note of observations of FA/CEO, KVIC, that hence forth

all major marketing issues related to D.S.Os including assessment of Khadi & V.I. Products for their quality, genuineness, packaging, labeling, hygiene etc and framing marketing strategy will be undertaken under the overall guidance of Expert Member(Marketing).

- 10. On opening of divisional office in karnataka, commission took note of observations of Member(SZ) regarding opening of one Divisional Office in North Karnataka having maximum concentration of Khadi Institutions in the region.
- a. Commission further took note of observations of Joint Secretary(ARI) that a conscious decision needs to be taken for opening of Divisional Offices and the criteria for opening such offices needs to be defined as the proposals for opening of regional offices are being received from many States across the country.
- b. Commission therefore decided to place a comprehensive proposal before Commission for consideration of the issue with full justification.
- 11. On workshop of tribal welfare sub plan in Ranchi:
 - 1. Commission took note and approved the observations of Dy. CEO (Comm. Cell) that a Workshop on Tribal Welfare Sub Plan is tentatively scheduled to be held on 20th & 21st February in Ranchi.
- 2. Commission also took note of the suggestion of Expert Member(RD) that an amount of Rs. 5.20 Lakhs which was earmarked for the workshop, is insufficient for effectively organizing the same and hence the Commission, recommended for enhancing the sanction of funds. The



requirement may be assessed by IFD and the required fund may be pooled from the Directorates of PMEGP, V. I. Coordination, Capacity Building and Publicity.

3. As suggested by Jt. Secretary and CEO, Commission decided to involve Ministry of Tribal Welfare and Tribal Development Corporation, TRIFED and National Scheduled Tribes Finance Development Corporation (NSTFDC) for partnering such eventful workshops for the welfare of tribals.

On issues arising out of discussion on action taken report of 639th meeting of the commission held on 23rd November 2016 at Mumbai.

I. AUDIT OF KHADLINSTITUTIONS:

Commission took note of observations of Jt.
 Secretary, that in the recently held State
 Directors Conference, Mumbai the issue of
 Director Audit at KVIC, Central Office, Mumbai

deputing audit staff for conducting Institutional audit was discussed where it was observed that Director(Audit) was directly deputing staff of State Offices for conducting audit of institutions because of which the functioning at the State Office levels were being hampered. It was further observed that the audit teams were anchored in the institutions for extended period of weeks together because of which the burden of excessive TA/DA had to be borne by the State Offices.

- 2. Commission therefore agreed to observations of CEO/FA that audit teams will be deputed (1) from within the zone and (2) for a limited and fixed period by which time they will conclude their audit exercise and report to State HQ.
- Commission also took note of observations of Expert Member(Mkt) that all KVIC Offices including State / Divisional Offices should go in for ISO Certification, before December, 2017.

The 'naysayers' world over have proved themselves wrong, whether it is Brexit, the much-talked about Trump election and finally, all about Narendra Modi.

There is one unmistakable class of people around the world that wouldn't accept anything that doesn't suit their desire. These people resort to wishful thinking and they want things to happen in a certain way. They create opinion, dominate public debate and invade every pseudo-intellectual forum just to propagate their notion of how things should be.

They even begin seeing the world moving as per their wish, albeit whatever be the reality. But when things do happen differently, their faith in the world crashes to the social abyss. And, since they cannot handle this heartbreak, they paint doomsday for the world with whatever just happened.

They just cannot accept anything that is not in line with their wish: it could be a mandate in democracy, a ruling of the supreme judiciary or the wisdom of the best minds. This group of people wouldn't accept anything that is not their wish — No

No Sapiens!

Consider Brexit. While the majority of the British had leaned towards it, particularly the Scottish people being in no doubt about it, the No No Sapiens decided it was bad for England. They rallied against it, created opinion, took to public debate and did everything possible in their capacity to scuttle what finally was the actual public opinion. And, when the power of democracy took a decision, they saw apocalypse happening at their front door. They derided democracy and lamented for being the only few, who knew what was best for their world.

Donald Trump's election followed a similar path. In a democracy, what is chosen is people's voice, and not an academic distinction of what is right or what is wrong. The American people rallied behind Trump, right from the very beginning. He won most public polls and debates. But No No



Sapiens saw the sun rising exactly in the opposite direction and defended their own skewed vision.

When they saw in the results of election their absolute failure to stay in touch with reality, they began professing how historically a mistake has been made by the oldest democracy of the world. Their self righteousness is far from being proven. But they do feel most righteous when they are least right.

The case with this elite class that has dominated Indian media and talk clubs is no different. The No No Sapiens are among us in every visible forum of the nation. They painted Prime Minister Narendra Modi as the incarnation of the worst demon when he began moving upwards in people's heart three years ago. They professed a sooth that India will break into a million pieces in religious unrest and anarchy, should he come to power as the Prime Minister.

They said that he will never make it to the Lutyens' Delhi. But when the people of India proved them hugely wrong and exercised their power of choosing their date with future, the No No Sapiens felt unsettled. But they took to every means and media to keep trumpeting their sooth that every decision the popular Prime Minister took was an inch closer to national disaster.

But what we are today and what kind of tryst we have with the destiny is all a clear pinnacle of coveted opportunity that we cherish and feel proud about. World over, India's march into future and glory are a matter of contemporary envy. India is firm-footed and fiercely progressive. The criticism of those with their weird vested interest keeps falling by the wayside into the insignificance of our national life.
