## CIRCULAR

Sub:- Modification in constitution of District Level Task Force Committee – reg.

As per the approved guidelines of the PMEGP scheme the District Level Task Force Committee headed by District Magistrate/District Collectors was to be constituted to scrutinize the applications based on the experience, technical qualification, skill, viability of the projects etc. It was also desired that the Task Force will shortlist the applications and call for an interview of the applicants.

- 2. To speed up the process as per O.O. No. 2027 dt.1-10-2008, it was desired that monthly meetings of DLTFC should be convened for early recommendation of the projects to the financing branches. On reviewing the progress of the scheme, it was observed that regular meetings of the DLTFC could not be held due to pre-occupation and busy schedule of the Dist. Magistrate/Collector.
- 3. Considering the practical difficulties as well as pendency of the applications at the field level, it has been decided that in case of pre-occupation of the Dist. Magistrate/Collector, Chief Development Officer (CDO) or Additional District Magistrate (ADM) could chair the DLTFC meetings and such meeting will now be held fortnightly instead of monthly basis.

In addition to functions mentioned in para (1) above, the DLTFC will also discuss the following issues in detail :

- (i) Status of pendency of projects with the banks
- (ii) Status of the projects sanctioned and rejected by the banks and the reasons of the rejection.
- (iii) Time taken by the respective decision making authorities of the banks, at various levels and ensure remedial measures.

- 4. In addition to above, DLTFC will also issue directives that projects should be forwarded directly to the decision making authorities of the bank depending on the size of the project in addition to respective financing branch. The detailed list of decision making authorities of the each bank should be supplied to the LDM of the district to ensure the same. The financing branches should also be instructed to sanction the project and take credit decision within 15-21 days of the receipt of the projects considering the recommendation of the DLTFC.
- 5. For better coordination between the implementing agencies as well as the banks, the DLTFC meeting will now be jointly convened by the GM, DIC and LDMs of the district. The districtwise status of the pendency/rejection of the projects is to be reported monthly to state head quarters for its compilation and reporting to CO KVIC, Mumbai.
- 6. The above procedure will come into force with immediate effect. The other-terms and conditions regarding constitution of the Committee etc. will remain unchanged.
