CIRCULAR

The Ministry of MSME, Govt. of India has launched a new Credit Linked Subsidy Scheme i.e. Prime Minister's Employment Generation Programme (PMEGP) w.e.f. 15th August, 2008 by merging REGP and PMRY that were in operation till 31st March, 2008. Khadi and Village Industries Commission is the nodal agency at National level for implementation of the scheme and the programme will be implemented through field offices of KVIC, Khadi and Village Industries Boards and District Industries Centers.

- 2. As per guidelines of the scheme, a "District Task Force Committee" has been constituted under the Chairmanship of District Collector/Magistrate in each district of the country for selection of potential beneficiaries for financing under the scheme. For this purpose and to have a uniform selection system, a score card formula has been devised with the approval of Ministry of MSME.
- 3. The following broad parameters may be taken into consideration while screening applications and interviewing applicants under PMEGP.
- Projects having greater potential to generate more employment
- Preference for young entrepreneurs
- Practical knowledge about the proposed project
- Bank worthiness of the proposal to filter out loan defaulters

- Applicants having EDP/Skill Development training
- Applicants belonging to the traditional artisans category
- Projects using innovative/proven technology
- Applicants belonging to the disadvantaged groups of society.
- Task Force may also accord preference for any other notable features/special strength of the project.
- 4. While evaluating the applications and interviewing the prospective beneficiaries under PMEGP the District Task Force Committee and Banks shall not give any marks. Instead applications may be screened and applicants interviewed on the basis of the parameters suggested above and recommendations recorded as good, satisfactory and unsatisfactory in order of preference on each of the suggested parameters.
- 5. Thereafter total with the sum total of the recommendatory remarks of each of the parameters, the District Task Force Committee will record the final recommendations as follows to facilitate selection of entrepreneurs / beneficiaries.
 - ❖ Good
 - Satisfactory
 - Unsatisfactory
- 6. The applicants / beneficiaries falling under the category of Good and Satisfactory may be selected for forwarding the application to Financing Bank for sanction of their project. The unsatisfactory category may be rejected by District Task Force Committee.

7. Feedback on the suggested parameters for the score card may be intimated to this office every month so as to apprise Ministry of MSME and to modify suitably if required.
