### **CIRCULAR**

Sub: To update old e-tracking system of PMEGP for timely consideration of application of PMEGP beneficiaries for up-gradation of 2<sup>nd</sup> financial assistance/loan.

This is in reference to Circular dtd. 07.06.2018 regarding guidelines for 2<sup>nd</sup> financial assistance under PMEGP for expansion of existing successful PMEGP/Mudra units.

1. It is to inform that the Directorate of Information Technology is in process for online application format for up-gradation of 2<sup>nd</sup> loan to the beneficiaries on e-portal. It is observed that most of the Field Offices have not updated the details of PMEGP beneficiaries sanctioned/releases of MM funds, name of financial banks etc. on e-tracking system of PMEGP from 2008-09 to 30.06.2016. This Directorate has issued circulars, letter etc. with a request to State/Divisional Offices to update details of PMEGP beneficiaries in e-tracking system to whom PMEGP loan has sanctioned/released from 2008-09 to 30.06.2016.
2. While consideration of application of PMEGP beneficiaries for up-gradation of 2<sup>nd</sup> loan, provision will be made to capture e-tracking details of 1<sup>st</sup> financial sanction/releases. Due to partial/incomplete updates on e-tracking, it would be difficult to capture 1<sup>st</sup> loan releases of the PMEGP beneficiaries.
3. It is therefore requested to update details of PMEGP beneficiaries who are interested to avail 2<sup>nd</sup> loan for up-gradation of PMEGP units. Subsequently it is once again requested to update e-tracking system within 15 days for beneficiaries who availed financial assistance from 2008-09 to 30.06.2016.

4. Adhering to the above directives, even in case of those applicants/beneficiaries who have availed financial assistance under PMEGP prior to functioning of e-portal i.e. before 2016-17, and desire to take benefits for up scaling their units under the second close of financial assistance under PMEGP admissible as per the guideline communicated earlier vide circular dated 07.06.2018 may be considered after completion of e-tracking which is mandatory in any case.

Non compliance of the same, it will be viewed seriously by Competent Authority and Ministry of MSME.
