CIRCULAR

Sub: Real time updating of PMEGP Applicant status view report- reg.

As a part of bringing transparency and accountability in implementation of PMEGP scheme, Ministry of MSME has introduced of e-tracking of PMEGP applications. KVIC has already developed the software for e-tracking whereby applications are track from the point of receipt to forwarding DTFC, forwarding to banks, sanctioned by banks, disbursement as well as Margin Money disbursement and upto the stage of physical verification and final margin money adjustment account. A circulars, DO letters were issued from time to time about mandatory entries of applications in the e-tracking system of PMEGP. During time to time Video Conferencing and Zonal Level review meeting the said matter was discussed and asked all concerned to take necessary steps. However, it has observed that entries of applications are not updated by concerned agencies, hence PMEGP beneficiaries could not get update/ Status of their application on e-tracking system.

2. As per the recent guidelines issued by Ministry of MSME, it is to inform that after the Online PMEGP Applicant status view report for applicants to view the details of their PMEGP loan application being maintained by KVIC. In this regard, it has been observed that the field showing the current status of the loan application in the report is not updated in a timely manner leading to ambiguity. The applicant suffers due to this as the current status in the online report is asynchronous with the actual status of the loan applications.
