**CIRCULAR**

**Sub: Online Submission of PMEGP Applications – reg.**

As per the recent guidelines issued by Ministry of MSME, emphasis has been given to fill up the applications ONLINE ONLY under PMEGP scheme.


2. By adopting the procedure of online submission of PMEGP applications, prospective beneficiaries may quickly fill up their applications and suitable e-tracking number will be obtained by them. This will help them the beneficiary to know the status of his/her duly filled in PMEGP application in the online system. Thus, the off-line system of submission of PMEGP application will not be in force by this way.

3 While filling up the online application, if the prospective beneficiary approaches the implementing agencies i.e. KVIC, KVIB and DICs then by taking assistance of existing Date Entry Operators available at implement agencies may guide to applicants/prospective beneficiaries for filling up the PMEGP application online and if these system is not available then they may direct applicants/prospective beneficiaries to nearby cyber café, computer training center/institutions etc for filling up the online applications by giving them information about the PMEGP website and other relevant information, in order to avoid difficulties while filling up the online application.

4. Instances have come to the notice that despite DLFTC recommendations, bunch of applications are lying pending with implementing agencies for forwarding the same to the financing bank branches. Therefore, all the applications which have been recommended by the DLFTC may be forwarded to the financing banks along with the required documents.
