Sub.: Criteria for PMEGP units under Animal Husbandry-reg.

CIRCULAR

- 1. This circular is in continuation of circular of even number dated 01.06.2021 through which the latest PMEGP Guidelines for the period 2021-22 to 2025-26 was conveyed.
- 2. Activities under Animal Husbandry like dairy, poultry, aquaculture, piggery and insects etc. were allowed under the scheme as per the aforesaid guidelines.
- 3. Various field offices including state Khadi & Village Industries Boards and District Industries Centres are sending representations to seek clarity on whether to consider Animal Husbandry units under the services sector or the manufacturing sector. Also, clarification is sought on whether the cost of livestock like cattle, chicks etc can be considered under the capital expenditure/ term loan.
- 4. In this regard, it has been decided to consider PMEGP units engaged in activities of Animal Husbandry under the services sector i.e., the maximum project cost eligible for subsidy shall be limited to Rs. 20 Lakhs only for the first loan.
- 5. The cost of livestock shall be considered under the capital expenditure/ term loan. However, the cost of livestock shall be considered based on the NABARD rates for the concerned state available on the NABARD website at the link provided below:
