### CIRCULAR

Sub: Disbursement of offline pending claims prior to 2016-17  
under PMEGP not allowed after 30<sup>th</sup> September 2019  
reg...

As you are aware that Ministry of MSME has introduced PMEGP online system from 01.07.2016 for improving transparency and accelerating the Programme of PMEGP implementation. As per the circular No. PMEGP/No. of Banks/2016-17 dt.14.11.2016 to approve the PMEGP old pending claims, a Committee consisting of Director (PMEGP), Dy.CEO (PMEGP) headed by CEO, KVIC was constituted and circulated.

Even after introduction of online portal w.e.f 01.07.2016, the MM claims prior to 2016-17 are being received from field offices even now. In order to complete the old MM offline claims, 30.06.2019 was set as a cutoff date to receive any claim. This issue was discussed during the Top Level Bankers Meeting in the presence of the representatives of the Ministry on 16.07.2019 in Mumbai and it was decided to fix the final cut off date as 30.09.2019 to receive the old claims. No claims shall be entertained after 30.09.2019.
