## CIRCULAR

Sub.: Physical Verification of PMEGP units through geo-tagging- Reg.

1. As per the PMEGP scheme guidelines, 100% physical verification (PV) is mandatory for all units setup under PMEGP. The process of physical verification is to facilitate the adjustment of margin money subsidy extended to the PMEGP units within the prescribed lock in period as per the scheme guidelines.

2. In this context circular no. PMEGP/PV/2020-21 dated 16.07.2020 and circular no. PMEGP/BFL/PV/Geotag/2021-22 dated 28.10.2021 was issued wherein physical verification was centralized for the units assisted from 2016-17 and onwards and modalities of physical verification of

PMEGP units respectively was communicated.

3. The PV reports submitted by the outsourced agency have been integrated Portal **PMEGP** existing the with

https://www.kviconline.gov.in/pmegpeportal.

4. The detailed modalities for processing of Physical Verification report uploaded by the PV agency and validation and approval by the DCOs and Approving Authority of respective Implementing Agencies (IAs) has already been communicated vide the aforesaid circular dated 28.10.2021.

5. During meetings with various Implementing Agencies through Video Conference from time-to-time various challenges faced by IAs were discussed along with remedies. One such issue faced by IAs was the nonavailability of edit option to the District Co-ordinators (DCOs) for making minor changes or correction of clerical/ typographical errors by the enumerators of PV agency that leads wrong calculation of eligible margin money subsidy.

6. Various representations and requests were received from IAs for providing solution to correct such errors in the PV report. Accordingly, in order to rectify these minor mistakes, an edit option under the PV tab of PMEGP portal has been made available. The IAs before validation and approval of the PV report can carry out the minor corrections by using the edit option available on the PMEGP portal henceforth. Also, the IAs can upload the relevant supporting documents to justify the edit action

exercised by them.

- 7. In order to remit the called back margin money by the financing banks, a facility for online transfer through NEFT/RTGS by generating the challan (based on MM Adjustment letter by IAs) has already been made available under the login of respective financing banks. No offline transaction for remitting the called back MM subsidy shall be entertained henceforth.
- 8. This may please be brought to the notice of all concerned for compliance.
