As you are aware that, PMEGP is the Flagship programme of Ministry of MSME implemented by the KVIC as National Nodal Agency. Presently applications under PMEGP are made through online system to bring transparency and fairness to the entire process. It is noticed that the **PMEGP** online operating officials DCO/concerned programme/portal which is password protected for processing of the applications in the State Offices tend to misuse the password in the event of their transfer to new headquarters. Instances have come to notice of Vigilance Section, KVIC, Mumbai, wherein officials concerned access the PMEGP portal of their previous headquarter from the present place of posting and interfere with the implementation of the PMEGP Programme in the State Office with the intention to influence the process and extract consideration from the applicant.

In order to check corruption by officials of KVIC while dealing with PMEGP applications, it is suggested that the password of the online programme should be immediately changed in the event of transfer of the dealing officials. This will deny access to the online portal and protect the innocent applicants.

All State/Divisional Directors including Nodal Officers should take note of above for immediate compliance so as to avoid any future consequences.

This may be treated as **MOST URGENT.**
