CIRCULAR

Sub: - Preventive Vigilance measures in implementation of PMEGP

Ref: - Note No.CVO Cell/46-2017/2017-18/209 dated 18.09.2017 of Chief Vigilance Officer

It is to inform that PMEGP online system introduced to bring transference and fairness for online submission of PMEGP Proposals. It is found that Beneficiaries still filing their applications through Bankers/middlemen and falling prey to their demand for money. Many Grievances/complaints have been received from applicants of PMEGP regarding extortion of money from them by middleman dealing themselves as authorised agents of PMEGP scheme.

It is to inform that on PMEGP e-portal it is clearly highlighted that KVIC /KVIB /DIC have not engaged any private Party/Agency/ Middlemen/ Franchise etc for promoting or sanctioning of PMEGP Projects or any financial assistance under PMEGP Programme and any potential entrepreneurs / beneficiaries dealing with such agency shall be doing it at their risk and consequences. Directorate of PMEGP has also issued letters / circulars from time to time in this regard.

It is directed that no staff should be entrusted with the work of PMEGP for more than 2 years in the field and at a single stretch. There should be compulsory rotation of work among the field staff.
