**Sub:- To give priority to Gram Panchayat under PMEGP Scheme - reg.**

It is to inform that as per directives received from Ministry of MSME, New Delhi requesting that in line with implementation of Saansad Adarsh Gram Yojna (SAGY), it has been decided to give priority to Gram Panchayats for specifying the role of panchayati Raj Institutions (PRIs) in Implementation of the PMEGP.
